It also examines the causes of women's underrepresentation in governance and decision-making as well as their implications for the country's socioeconomic development and describes strategies for increased women's representation in governance and decision-making in Nigeria. This study relies on political-culture and liberal-feminist theory and adopts a mixed-method research design involving quantitative and qualitative methods. It uses multistage sampling in selecting Nigeria's South-East, North-West and South-West geopolitical-zones and 1206 women of electoral age for the study survey conducted using structured questionnaire and in-depth interview"—Provided by publisher.
